Crittenton has designed various curricula and workshops to educate young girls from low income families on reproductive health and career preparation planning. Most importantly, they attain a belief in their ability to succeed, even in challenging situations. The results are life-changing; Crittenton girls are staying in school, avoiding pregnancy, graduating from high school, and going on to college and finding jobs.
